36-3231. Surrogate decision makers; priorities; limitations. A. If an adult patient is unable to make or communicate health care treatment decisions, a health care provider shall make a reasonable effort to locate and shall follow a health care directive. A health care provider shall also make a reasonable effort to consult with a surrogate.

## **36-3231 - Surrogate decision makers; priorities; limitations**

Surrogacy arrangements made between the surrogate mother and the intended parents must respect the AHR Act and provincial and territorial laws. Depending on where the surrogate mother and intended parents live, domestic and foreign laws may also apply and could affect the surrogacy arrangement.
